


Thomas H. Gould/Paul R. Marsh \$1,000 Scholarships Available

Protect Your Account with ECSFCU Alerts!



ECSFCU offers several ways to protect your account from unauthorized access by scammers that always seem to find new ways to try to steal your information and money. One of the best ways to ensure that your account is protected is to set up automatic alerts within ECSFCU's Online Banking. These alerts can notify you via email, text message to your mobile phone, or a notification via your ECSFCU Mobile app, in near real-time when a transaction or other security

event happens on your account. Some of the available

security alerts include:

- Any Change in Contact Information (Address, Phone Number, Email Address)
- Any time your account is logged into via Online Banking or Mobile Banking
- Any time your password is requested to be reset
- When your balance falls below a certain dollar amount of your choosing
- When a transaction occurs over a certain dollar amount of your choosing

Getting alerted quickly and notifying ECSFCU of anything unusual ensures that ECSFCU can act quickly to protect your account! Contact ECSFCU Member Services at **619-588-1515** if you would like help setting up your alerts today.
