

"2021 Educator's Tour to the French Riviera or to U.S. National Parks"

Contest Rules
Open to member-owners of East County Schools Federal Credit Union

No purchase necessary to enter or win.

All East County Schools Federal Credit Union member-owners are eligible to complete the Survey in order to secure one (1) entry into this ECSFCU Grand Prize Drawing. East County Schools Federal Credit Union member-owners that have an ECSFCU Checking Account as of February 8, 2021 will receive four (4) additional entries into this Grand Prize Drawing. An additional five (5) entries for this Grand Prize Drawing will be awarded to any qualified entrant that has an outstanding ECSFCU loan balance of \$10,000.00 or more as of February 8, 2021.

1. ELIGIBILITY

This "Promotion" is offered and open only to Member-owners of East County Schools Federal Credit Union that are 18 years of age or older at the time of entry. Employees, directors and volunteers of ECSFCU, affiliated and subsidiary companies, advertising and promotion agencies, legal advisors, and the immediate family or members of the households of such employees, directors and volunteers are not eligible. By entering, you agree to these Official Rules and the decisions of ECSFCU, which are final and binding in all respects.

2. PROMOTIONAL PERIOD

Promotional period begins on January 4, 2021 at 5:00 a.m. Pacific Time (PT), and ends on February 8, 2021 at 11:59:59 p.m. PT ("Promotional Period"). The Promotional Period shall consist of consecutive 24-hour periods (each a "Day") commencing as of 5:00 a.m. PT each day and ending on the following day at 4:59:59 a.m. PT, except that the final Day of the Promotional Period shall end at 11:59 p.m. PT. ECSFCU reserves the right to terminate the promotion by giving notice during any calendar month, deemed appropriate by ECSFCU, in which case the Promotion will terminate on the date established in the notice. The Grand Prize will nevertheless be awarded as stated below in the event of any early termination based upon all entries received prior to the moment of termination.

3. ENTRY

There are 2 ways to enter:

<u>Online Method:</u> To enter the Grand Prize Drawing by means of the Internet, complete the survey form from the link on <u>www.EastCountySchools.org/EducatorTours</u>.

The number of entries earned for various activities or actions are specified in a manner determined by ECSFCU. ECSFCU reserves the right to offer additional methods of entry from time to time during the Promotional Period. The number of entries for any activity or action may be changed by ECSFCU at any time in its sole discretion.

<u>In-Branch:</u> To enter the Grand Prize Drawing by means of the in-branch registration, come in to our El Cajon Main branch at 1069 Graves Avenue #100, El Cajon, CA 92021. Complete the Survey form by filling out your full name, date of birth, primary telephone number (including area code), email address, and any other requested fields and follow the other instructions set forth in the branch.

Unless otherwise specified in writing on the web site, any other attempt at online or in-branch entry is void.

Entrants may not enter with multiple email and/or multiple identities nor may entrants use any other device or artifice to obtain more than the maximum number of entries (10). Any entrant who attempts to participate with multiple email and/or multiple identities or uses any device or artifice to obtain more than the maximum number of entries may be disqualified. ECSFCU reserves the right to increase or decrease the maximum number of entries permitted throughout this contest. Any such increase, decrease will be announced, in a manner deemed appropriate by ECSFCU in which case the increase, decrease will become effective on the first day following the date on which notice is given. ECSFCU shall, however, be under no obligation to make any such increase, decrease.

No participant can receive more than the maximum number of permitted entries for the Promotional Period, which number shall be 10.

4. DRAWING

One (1) Grand Prize Winner will be selected by random drawing from all eligible entries received. ECSFCU may at its sole discretion conduct one or more random interim drawing(s) at the conclusion of the Promotional Period. Drawing(s) for the Grand Prize will take place on or about February 10, 2021 @ 10:00 am. The drawings for one (1) \$100 Visa Gift Card will take place on or about February 10, 2021 @ 10:00 am. Drawings will be conducted under the supervision of ECSFCU. Once the Grand Prize Winner has been selected, the amount of the Grand Prize shall be determined as described in Section 5 of these Rules.

To be declared a Winner, you do not need to be present at the drawing.

5. PRIZE/ODDS

(1) Grand Prize: There will be one Grand Prize awarded for the entire Promotional Period. The Grand Prize winner will receive a reservation for the winner's choice of the "2021 Educator's Tour to the French Riviera", departing on July 10, 2021 and returning July 18, 2021 or the "2021 Educator's Tour to U.S. National Parks", departing July 18, 2021 and returning July 25, 2021. These tours are organized by the San Diego East County Chamber of Commerce and East County Schools Federal Credit Union to include round trip airfare, hotel lodging, ground transportation, selected meals, and entrance to scheduled historic and cultural sites as described in the 2021 Educator's Tour "Spotlight on the French Rivieria" brochure or "Discover America's Cowboy Country" brochure (see website for trip details). Odds of winning

the Grand Prize depends on the number of eligible entries received for that drawing. ECSFCU reserves the right at its sole discretion to provide the winner with a substitute Grand Prize or other prize of equal or greater value. Unless you previously declined to attend the "2021 Educator's Tour to the French Riviera or the 2021 Educator's Tour to U.S. National Parks" and selected only to be in the drawing for the \$100.00 Visa Gift Card (second prize drawing), your entry is your promise to attend this trip should your entry be selected.
